3. The program objectives and outcomes, and course objectives and outcomes added to the PG Syllabus were discussed and approved.

3. There was a change of the title of the course for ENG-402 (Elective-B, American Literature) in Semester-IV from "The Great American Novel" to "American Fiction" as the experts objected to the use of the word "Great" in the course title.

4. As per the recommendations of the experts, there was a change of content for the following courses:

i. T.S. Eliot's "The Fire Sermon" from *The Wasteland* was replaced with T.S. Eliot's "The Hollow Men" in Unit-III of ENG 202: 20th Century English Literature and Thought in Semester-II because the experts suggested that "The Fire Sermon" cannot be taught exclusively without referring to the entire text of *The Wasteland*.

ii. D.H. Lawrence's *Women in Love* was removed as an option from Unit-II of ENG 202: 20th Century English Literature and Thought in Semester-II in order to avoid confusion in teaching and question-setting.

iii. Albert Camus's *The Outsider* was replaced with Italo Calvino's *Invisible Cities* in Unit-IV of ENG 203: European Novels in English Translation in Semester-II as Flaubert's *Madame Bovary* was already included from French nationality.

iv. Mahasweta Devi's "The Breast Giver" was replaced with Ismat Chughtai's "The Quilt" in Unit-III of ENG 204: Women's Writing in Semester-II as Mahasweta Devi's *Mother of 1084* had already been included in the course on Gender Studies.

5. Paper-711, Changing Trends in Literary and Language Studies for PhD coursework was replaced with Paper-711, Changing Trends in Literary Studies, and the newly designed course was approved by the BOS.

6. The complete list of question-setters, examiners and moderators for UG, PG, PhD Course work prepared by the department was approved by the BoS members.
