## Board Recommendations:

### A) The Syllabus modification for PG Course is suggested for the following Papers such as :-

1. These are the list of the Papers which will continue as it was prescribed in the earlier syllabus- 101, 102, 103, 104, 201, 202, 203, 204, 301, 302, 303, 306, 401, 402, 405.
2. 105- Unit-I, II & III are remain same. Unit-IV is replaced by षट् सम्प्रदाय.
3. 205 - कादम्बरी ( Unit-III & IV) is replaced by रघुवंशम् (प्रथमसर्ग).
4. 206 A - उत्तरमेघ (Unit-I & II) is replaced by मुद्राराक्षसम्.
5. Specialisation Papers are replaced with Compulsory Papers. Special papers 304 (A,B,C), 305 (A,B,C), 403 (A,B,C), 404 (A,B,C) is replaced by Compulsory Papers 201 (Vedic Literature), 305 (Grammar), 403 & 404 (Literature)
6. 305 will be replaced by 201 and 205 replaced by 304.

### B) Addition of the Syllabus for UG Course




