After the introductory remarks by the Registrar Smt. Jugaleswari Dash, Hon'ble Vice Chancellor and Chairman of the PMU welcomed all the members to the meeting and requested them all to participate and deliberate for the larger benefit of the institution.

The RUSA Coordinator Dr. Uma Charan Pati made a power point presentation to all the members about the progress made so far as regards the spending of the sanctioned amount strictly as per the requirement of the University and in conformity with the mandate of the RUSA.

The minutes of the 10th PMU and action taken so far were presented before the members of the PMU for their perusal.


After detailed discussion, the following decisions were taken in the PMU meeting:-

- The PMU approved the proposal for diversion of fund from Renovation of 1st floor of Old Examination building to the Additional Work of Library Building. Earlier Administrative Approval had been accorded for renovation of the 1st floor of old examination building and the estimated cost of the project was Rs. 38,51,900/-. An amount of Rs.12,71,127 released as 1st installment to OPHWC. Due to delay in the project by OPHWC the fund has been diverted to the Additional Work of Library Building. The estimated cost of the library building work is Rs. 16,20,126. Further, the balance amount of Rs. 3,48,999/- has been transferred to OPHWC.
- The PMU approved the proposal for following 07 nos. of Repair & Renovation projects submitted by the OPHWC with an estimated amount of Rs. 40,87,135/-. The amount may be paid from the surplus funds available with OPHWC from the completed projects funded by RUSA i.e. Repair & Renovation of 04 nos. of Ladies Hostel and Repair Renovation of Library Building.

- As more than Rs. 1,30,00,000/- surplus amount is available with CPWD out of the completed projects, a letter is to be sent to the Superintending Engineer, CPWD for settlement of Accounts. And surplus amount may be used in other projects.
- As RUSA Odisha diverted Rs. 1 crore committed fund to other institution as per the Govt. of India Financial Rule, a letter may be written to RUSA Odisha for release of the diverted fund immediately so that rest of the work could be completed.
- An uncommitted amount of Rs. 30,82,702/- RUSA fund is remaining with us. PMU approved Additional work of 2nd floor of old Examination building with an estimated cost of Rs. 53,22,791/-. The balance amount of Rs. 22,40,089/- will be paid from other surplus fund of completed projects.
- Dr. Sushree Sasmita Pati, Dy. CoE requested for creation of a strong room in the Examination section. Hon'ble Vice Chancellor suggested to use the record room of the Admin Building.
- Chairman, PGC informed the PMU about requirement of a central space with small equipment for all the science departments. As less amount has been available under RUSA fund, the proposal may be implemented after receiving the second installment of RUSA grant, if any.
- Dr. Kamadeba Sahu suggested some proposals like Development of a garden in the Quadrangle area, Development of the area adjacent to the JPPG Hostel and back side of Chemistry Department, Toilet facility at the 2 nos. of Security room, Creation of roof above the Statue of goddess Saraswati located in front of the main gate. GMU Administration would take up these projects after receiving the expected second installment of RUSA grant.

The meeting ended with a Vote of Thanks proposed to the Chair and others by the Deputy Registrar and Co-ordinator Dr. Uma Charan Pati.
