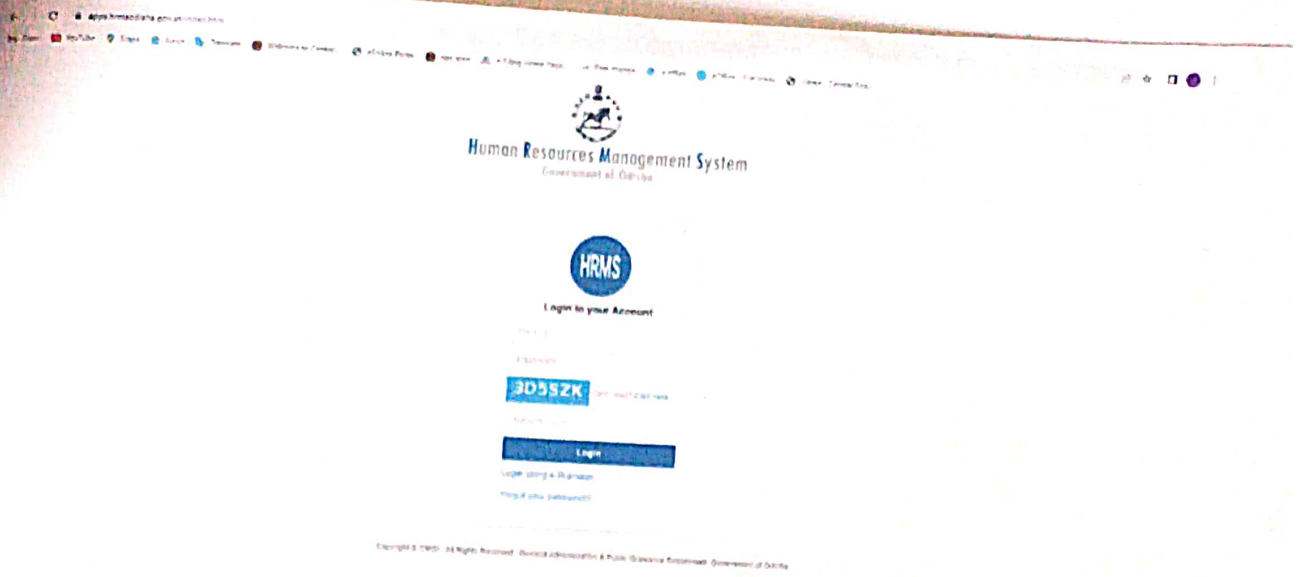

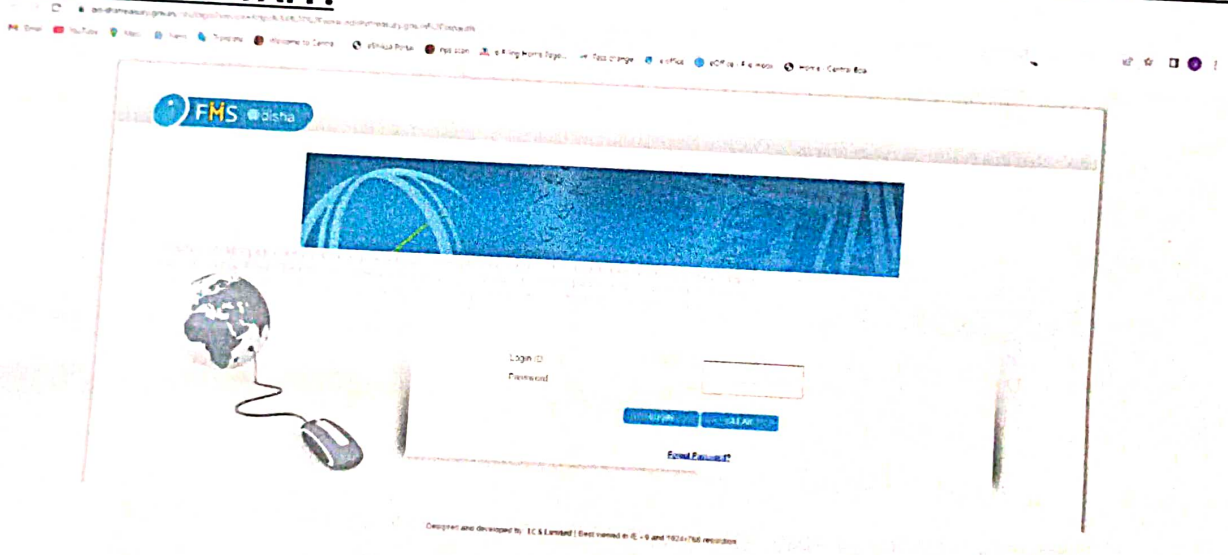

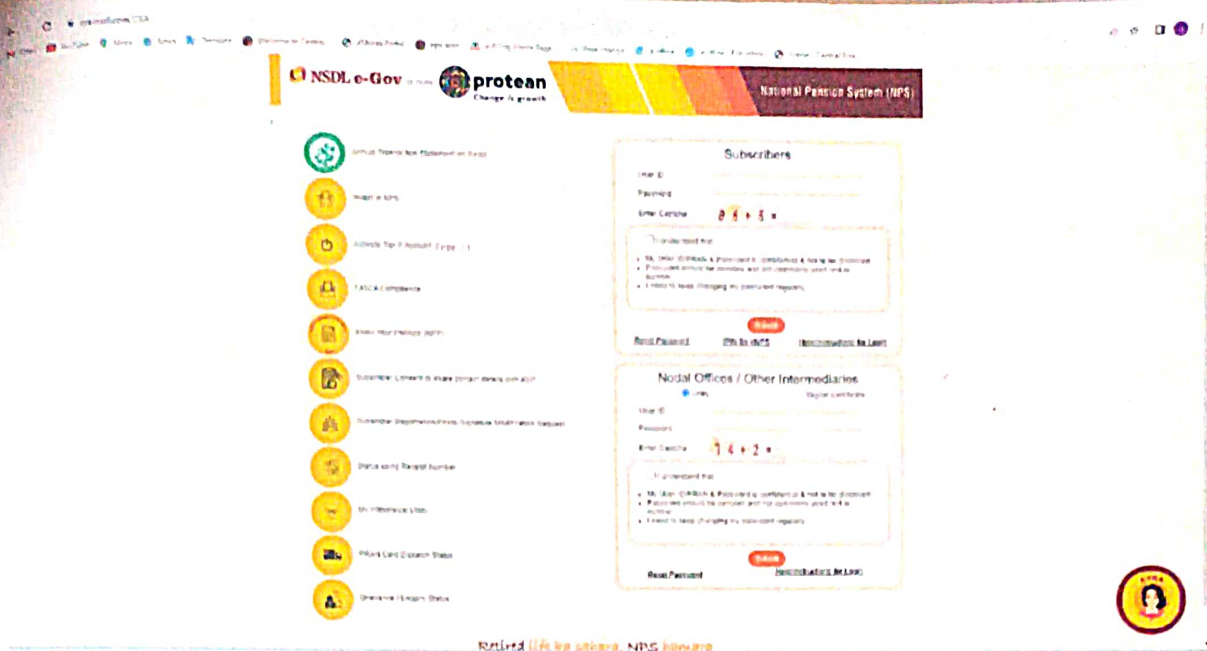


4. POST RETIREMENT BENEFIT & OTHER ONLINE BILL PREPARATION OF DEPLOYED STAFF.

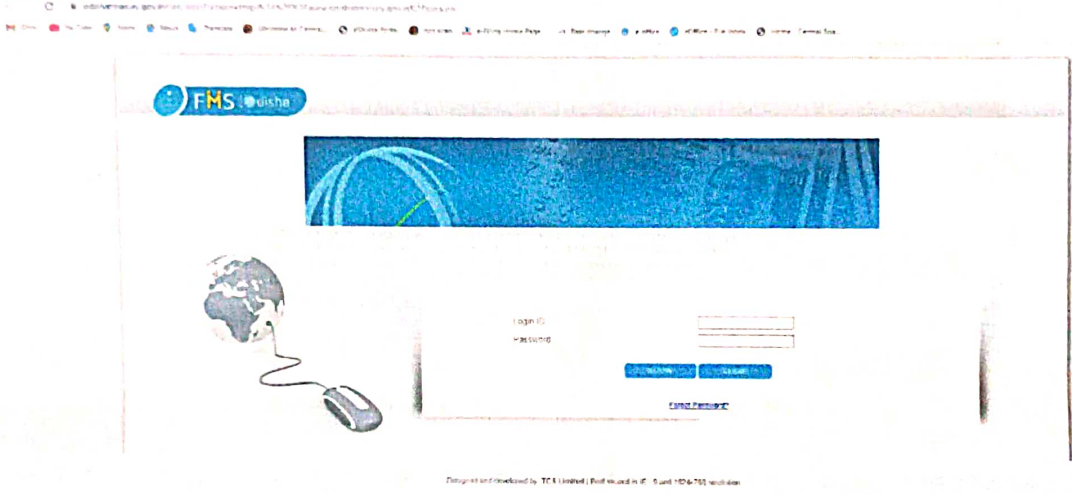

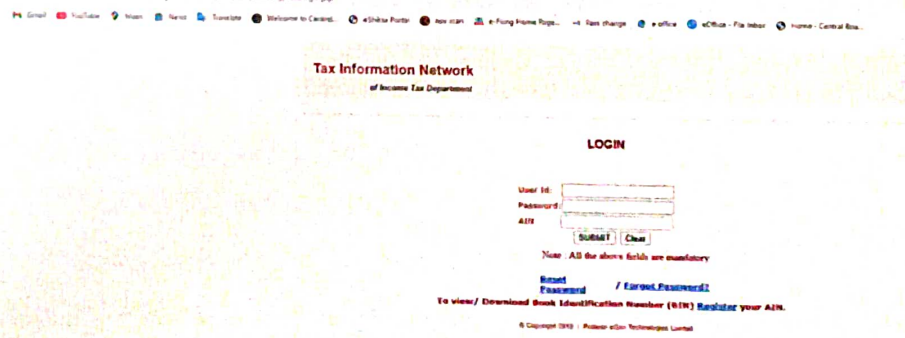

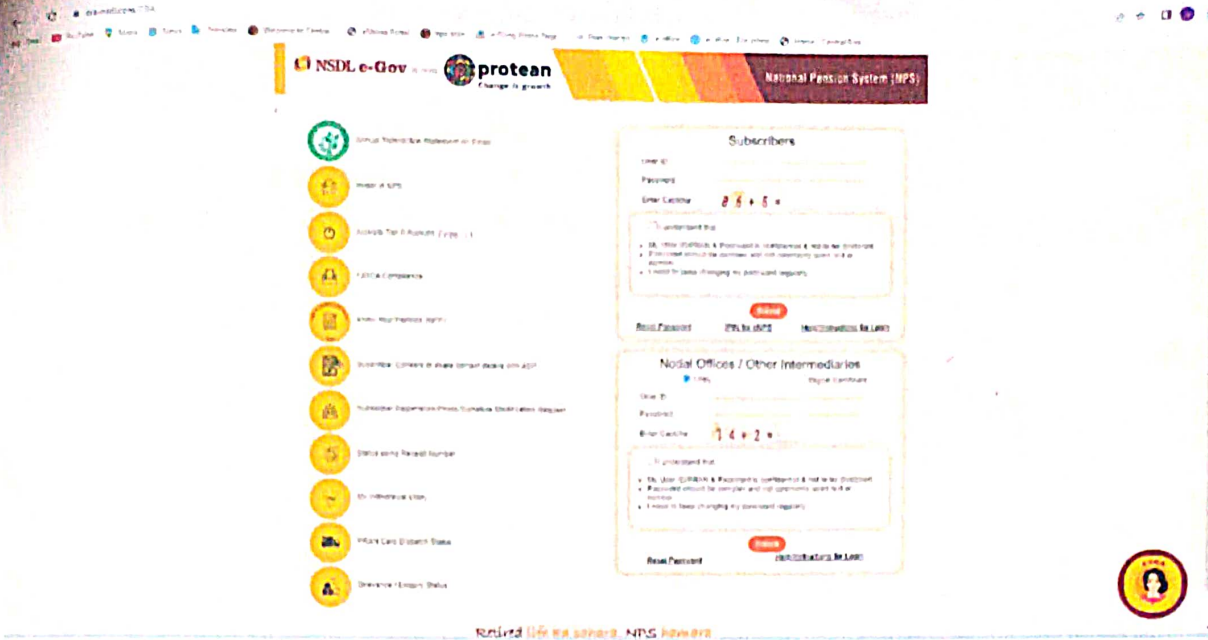
6. DIFFERENT FUNCTION IN CONNECTION WITH NEW PENSION SYSTEM OF DEPLOYED STAFF.

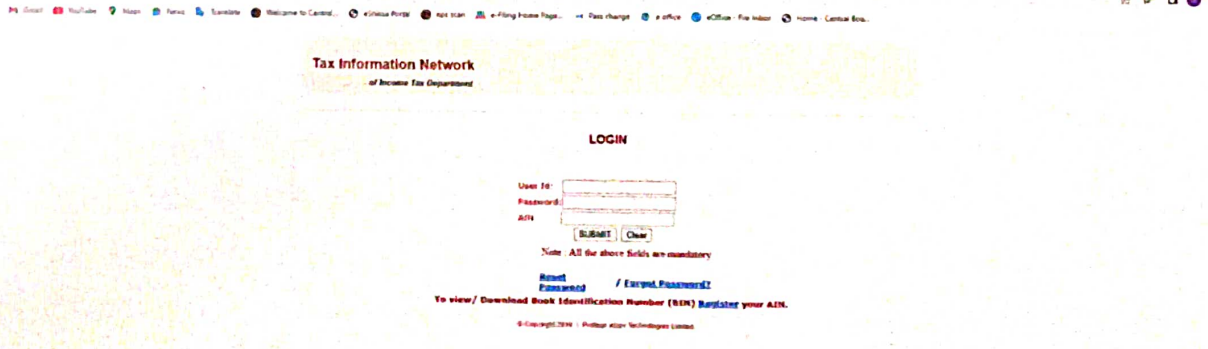

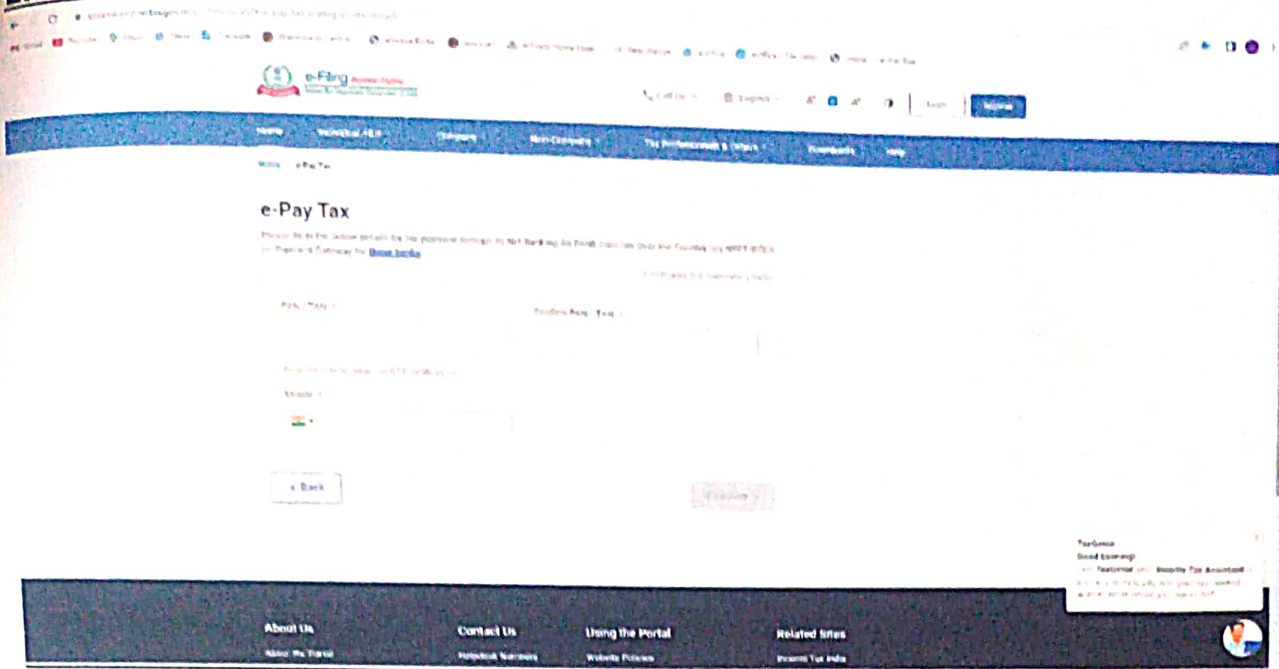

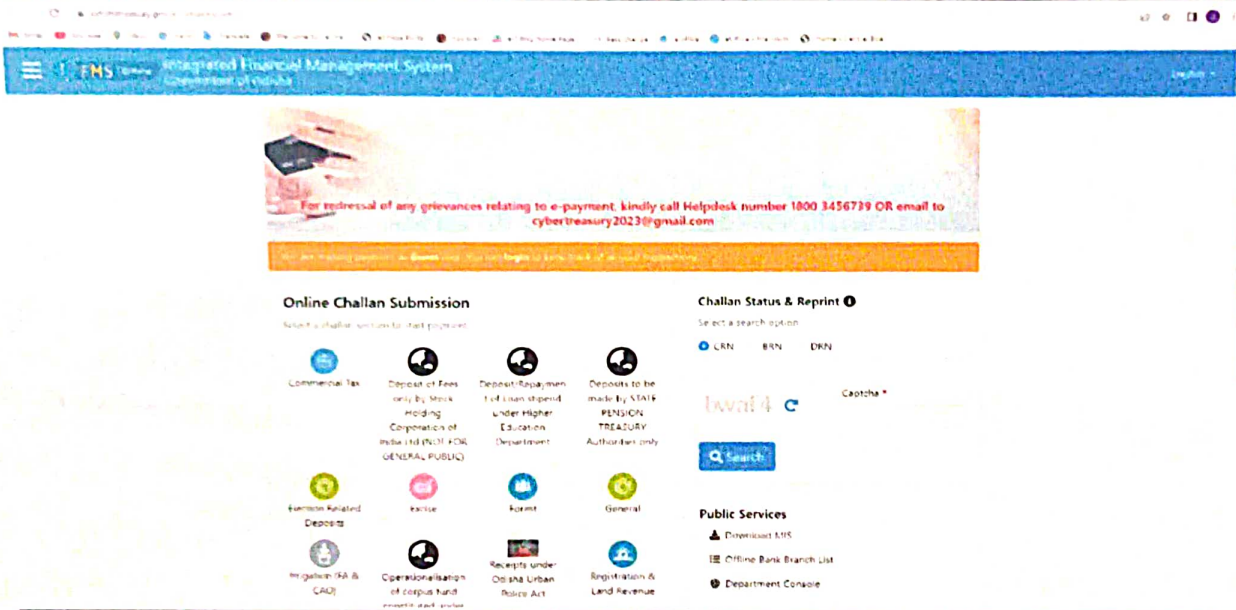
